### ♦ The Purpose of the Establishment of NAI Tosei Japan, Inc.

Tosei Group sees its expansion into the global market as one of its key agendas in the medium-term management plan "Next Stage 2014" and aims to develop such overseas operations to be a contributor to the existing businesses and to diversify its business portfolio.
